RESOLUTION #12445, November 24, 1998

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the County recognizes its statutory obligation to the poor under Sections 205.580 et seq., RSMo and 205.580 et seq.; and,

WHEREAS, the County and Countryside BMX desire to enter into an agreement, a copy of which is attached hereto and incorporated herein by reference, whereby BMX will use County funding to subsidize the participation of indigents in its activities; and,

WHEREAS, the cost to the County under this agreement is \$10,000.00, to be paid in one lump sum upon its execution; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the agreement is hereby approved and that the County Executive is authorized to execute the agreement on behalf of the County, and that the Director of the Department of Finance is authorized to make all payments, including final payment, on the agreement...Attorney
