ORDINANCE # 3261, June 10, 2002

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "LB" (Local Business) District and the "RU" (Residential Urban) District so that there will be transferred from District LB to District RU a tract of land described as follows:
