IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE repealing 5037., Jackson County Code, 1984, relating to docks on Prairie Lee Lake. ORDINANCE #2747, October 20, 1997

INTRODUCED BY Fred Arbanas, County Legislator

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section A. Enacting Clause. Section 5037., Jackson County Code, 1984, is hereby repealed.

[5037. Docks on Prairie Lee Lake, Permit Required.

Owners of lakeside property at Prairie Lee Lake may be permitted to construct docks on the lake in accordance with this section. Such docks shall be compatible with other docks and lakeside residences in terms of size, type, and method of construction. No person shall erect, construct, enlarge, alter, repair, move, improve, remove, convert, or demolish any dock or similar structure on the waters of Prairie Lee Lake, or cause or permit the same to be done, without first obtaining a valid permit from the director of parks and recreation.

5037.1 No Fee for Lakeside Property Owners.

No fee for a permit under this section shall be assessed against an owner of lakeside property at Prairie Lee Lake.

#### 5037.2 Standards.

The issuance of permits under this section shall be governed, to the extent practicable, by the standards of chapter 54 of this Code, the Uniform Building Code, and the policy enunciated in this section.]

Effective Date: This ordinance shall be effective immediately upon its signature by the County Executive.
