WHEREAS, the County did, by Resolution 9182, dated March 9, 1992, enter into a contract with Wells Fargo Armored Services of Riverside, MO, in the amount of \$22,847.57 for armored car services for use by various county departments; and,

WHEREAS, the proposed 90-day extension and increase to this contract is necessary to allow the County sufficient time to rebid this contract, and this increase will not exceed \$9,058.11.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the increase to the aforesaid contract is approved and the Director of Purchasing is authorized to execute the necessary documents on behalf of the County; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to make all payments, including final payment on the contract.
