**RESOLUTION #17714**, October 31, 2011

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, by Resolution 17597, dated May 23, 2011, the Legislature did award a contract for LEWeb law enforcement computer information services to the Regional Justice Information Services (REJIS) Commission, of St. Louis, MO, as an acquisition from another governmental entity, at a cost to the County for 2011 not to exceed \$11,592.00; and,

WHEREAS, by Resolution 17657, dated August 11, 2011, the Legislature did authorize a first

addendum to the contract with REJIS to allow the Sheriff's Office to access information for the Conceal Carry Weapons Program; and,

WHEREAS, the Jackson County Multijurisdictional Drug Task Force is also in need of a subscription for the REJIS LEWeb law enforcement computer information services, at an additional cost to the County for 2011 not to exceed \$397.50; and,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of Finance and Purchasing be and hereby is authorized to execute for the County a second addendum to the agreement with the REJIS Commission, of St. Louis, MO; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the agreement, and all addenda thereto.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
