WHEREAS, the Director of Purchasing pursuant to Section 1040.05 of the Jackson County Code, 1984, recommends the purchase of one 1997 4-door, 4x4 Chevrolet S10Blazer, compact utility/special purpose vehicle from Sonny Hill Motors of Platte City, MO, in the actual amount of \$23,493.00 by the Jackson County Drug Task Force, under the Joint Governmental Fleet Bid, City of Lee's Summit, MO, Bid No. 67-003 of October, 1996, an existing government contract of the Mid-America Council of Public Purchasing; and,

WHEREAS, Section 1064.00, Jackson County Code, 1984, requires that, for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; and,

WHEREAS, in order to fund this purchase a transfer within the 1996 Anti-Drug Sales Tax Fund is necessary; and,

WHEREAS, the County Executive recommends such transfer; now therefore,
