WHEREAS, it was with great sorrow that family and friends learned of the death of Judge Salvatore "Sal" Nigro; and,

WHEREAS, Judge Nigro received his B.A. from the University of Notre Dame and J.D. degree from the University of Missouri-Kansas City; and,

WHEREAS, after serving two years in the U.S. Air Force as a captain, Judge Nigro entered private law practice in 1954 and was later appointed to the bench as a municipal court judge in 1967 where he served until his retirement in 1990; and,

WHEREAS, in 1974 Judge Nigro was honored as Columbian of the Year by the American Sons of Columbus and UNICO Man of the Year; and,

WHEREAS, after retirement, Judge Nigro served on the Jackson County Merit Commission; and,

WHEREAS, Judge Nigro held memberships in the American Bar Association, American Judicature Society, North America Judges Association, UNICO, Missouri Judges Association, Italian-American Unification Council, Kansas City Bar Association, Kansas City Area Safety Council, and Phi Alpha Delta; and,

WHEREAS, Judge Nigro is survived by his wife Donna, son and daughter-in-law Bill and Patti Nigro, son and daughter-in-law Torre and Lisa Nigro, daughter and son-in-law Michele and Pat Haggerty, daughter and son-in-law Karen and Joseph Hilboldt, daughter and son-in-law Mary Lou and John Quinn, daughter and son-in-law Julie and Sam Santee, and stepson and wife Jeffery and Jo Lynne Gouldie; and,

WHEREAS, he is also survived by grandchildren Emily, Josie, Courtney, Suzanne, Amy, Laura, Sam, Rachel, Brian, Dan, Kevin, Katie, Molly, Meg, Elizabeth, and Sam; and,

WHEREAS, Judge Nigro will be greatly missed by those who knew and loved him; now therefore,
