WHEREAS, the Purchasing Director has recommended that award be made to Mid-Continent Micrographics of St. Joseph, MO, for the reason that its is the lowest and best bid as set forth in the attached recapitulation and analysis; and,

WHEREAS, the Director of Records has requested that additional funds be encumbered on this contract, so he can order additional

microfilming services, if necessary; now therefore,
