WHEREAS, the Blue Springs Lake Marina has a need for an upgraded fuel line and dispensing system; and,

WHEREAS, the Director of Finance and Purchasing has solicited formal written bids on Invitation to

Bid No. 36-14 for the furnishing of this system for use by the Parks + Rec Department; and,

WHEREAS, a total of twenty-one notifications were distributed with the three lowest responses received and evaluated as follows:

WHEREAS, the Director of Finance and Purchasing recommends that award be made to Petroleum Equipment of Kansas City, MO, as the lowest and best bidder; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be, and hereby is authorized to make all payments, including final payment on the contract.
