ORDINANCE NO. 5643, August 15, 2022

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RS" (Residential Suburban) Districts, so that there will be transferred from District AG to District RS a tract of land with a street address of 13010 SE Howard Road, legally described as follows:
