BE IT RESOLVED by the Legislature of Jackson County, Missouri, that the Legislature does hereby honor the life and achievements of Ronald McFadden, a true Kansas City treasure, whose talent, passion, and generosity will be deeply missed by all who knew him; and,

BE IT FURTHER RESOLVED that the County Legislature does hereby recognize Ronald McFadden's contributions to the cultural and artistic landscape of Kansas City and his unwavering commitment to excellence and innovation in music and education; and,
