WHEREAS, the only bid received was from Ray-Carroll County Grain Growers, Inc., of Richmond, MO; and,

WHEREAS, the Purchasing Director has recommended that award be made to Ray-Carroll County Grain Growers, Inc., of Richmond, MO, for the reason that it has submitted the lowest and best bid; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget.
