WHEREAS, the Director of Finance and Purchasing has solicited bids on Electronic Solicitation No. BB200665 for the furnishing of traffic signs and supplies for use by the Parks and Recreation and Public Works Departments to provide for departmental needs for the upcoming twelve-month period,

with annual options to extend for terms not to exceed an additional total of twenty-four months; and,

authorized to execute for the County any documents necessary to the accomplishment of the award and any extensions; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contracts and subsequent extensions, to the extent that sufficient appropriations to the using spending agencies have been made in the then current Jackson County budget.
