WHEREAS, the Truman Heartland Community Foundation has awarded a grant in the amount of \$5,011.38 for the purchase of a commercial washing machine for use at the Regional Animal Shelter; and,

WHEREAS, the grant requires matching funds in the amount of \$1,192.62, which have been furnished by Great Plains SPCA, the County's contracted manager of the Regional Animal Shelter;

and,

WHEREAS, an appropriation is necessary to place the grant and matching funds in the proper spending account; and,

WHEREAS, the County Executive recommends this appropriation; now therefore,
