WHEREAS, the County has a need for vehicles for use by the Parks and Recreation Department; and,

WHEREAS, the Director of Finance and Purchasing, pursuant to Section 1030.04 of the Jackson County Code, 1984, recommends the purchases under the terms and conditions of 2007 model year Kansas City Metro Vehicle Bid, IFB No. 2754-0-2006/RP of the Mid-America Council of Public Purchasing issued by the City of Olathe, KS, an existing government contract; and,

WHEREAS, Section 1030.04, Jackson County Code, 1984 requires, that for any such purchase in excess of \$25,000, the Director of Finance and Purchasing shall submit the purchase to the County Legislature for approval; and,

WHEREAS, award as recommended would result in the following purchases:

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payments on the contract thereby made.
