**RESOLUTION 13651**, April 2, 2001

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, the County did, by Resolution 13428, dated November 13, 2000, enter into an agreement with County Court Services, Inc., of Kansas City, MO, to provide substance abuse and/or other counseling services for the County's Drug Court Program, in the amount of \$576,284.00; and,

WHEREAS, due to an oversight, sufficient funds for the rental of the Assessment Center, which is used by County Court Services in this program, were not included in this Agreement; and,

WHEREAS, the proposed First Addendum to this Agreement, a copy of which attached hereto, is necessary to provide for these rent payments at an actual cost of \$20,400.00; and,

WHEREAS, a transfer within the 2001 Anti-Drug Sales Tax Fund is necessary to cover payments due under this First Addendum; and,

WHEREAS, the County Executive recommends said transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be and hereby is made within the 2001 Anti-Drug Sales Tax Fund:
