**RESOLUTION 13216**, May 15, 2000

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, representatives from all municipalities in Jackson County whose police departments sponsor Drug Abuse Resistance Education (DARE) or similar anti-drug programs have made a joint request to the COMBAT Commission and County Legislature, regarding the formula for Jackson County's funding of these programs for the 1999-2000 term; and,

WHEREAS, the consensus reached among the municipalities and COMBAT staff was that these programs be funded in the following amounts:

 WHEREAS, at its meeting of May 9, 2000, the COMBAT Commission endorsed the recommendations of the municipalities and agencies involved; and,

WHEREAS, the attached form contract provides a suitable mechanism by which the requested funds can be transferred to the participating municipalities; and,

WHEREAS, a transfer within the 2000 Anti-Drug Sales Tax Fund is necessary to effect the recommendation with regard to the D.A.R.E. programs; and,

WHEREAS, the County Executive recommends such transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be and hereby is made within the 2000 Anti-Drug Sales Tax Fund:

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the contracts.
