WHEREAS, the Legislature did, by Resolution 11135, dated January 22, 1996, authorize the County Executive to execute an Agreement with Niles Homes for Children, in the amount of \$30,000.00 on the recommendation of the Jackson County Anti-Drug Sales Tax Fiscal Commission; and,

WHEREAS, upon recommendation of the COMBAT Commission, the County now desires to extend this agreement for an additional nine months, at no additional cost to the County; and,

WHEREAS, the attached First Addendum to Agreement provides a suitable mechanism for extending this agreement; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to enter into the attached First Addendum to Agreement with Niles Home for Children; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement.
