INTRODUCED BY John Patrick Burnett, County Legislator

WHEREAS, the County desires to purchase a 4-door 1998 Ford Crown Victoria sedan for use by the Drug Task Force; and,

WHEREAS, the Director of Purchasing pursuant to Section 1040.05 of the Jackson County Code, 1984, recommends the purchase from Joe Machens Ford of Columbia, MO, under an existing state of Missouri government contract; and,

WHEREAS, Section 1064.00, Jackson County Code, 1984 requires, that for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the purchase under the existing government contract be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

RE IT ELIPTHED DESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payments on

the contract. Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
