WHEREAS, the purpose of such closed meeting is to conduct privileged and confidential communications between the Legislature and the Jackson County Counselor in connection with the status of litigation and the status of negotiations with County employee groups; and,

WHEREAS, such closed meeting is allowable under Section 610.021(1) and (9) of the Revised Statutes of Missouri; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature and

the Jackson County Counselor be authorized to hold a closed meeting during the regularly scheduled meeting of the Legislature on this date to discuss the status of litigation and the status of negotiations with County employee groups.
