WHEREAS, the County has a need for a temporary construction easement for the widening of Colbern Road, Phase II Project; and,

WHEREAS, the owners of the property have agreed to convey the necessary temporary construction

easement to the County as set forth in Exhibit "A"; and,

WHEREAS, the Director of the Department of Public Works recommends acceptance of the temporary construction easement; and,

WHEREAS, the Director of Public Works also recommends a lump-sum payment of \$9,010.00 to John and Kimberly Sheehy, trustees for the property owners, for the temporary construction easement; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the aforementioned temporary construction easement, further described in the attached "Exhibit A", be and hereby is accepted and that the Manager of Finance be and hereby is directed to issue a lump sum payment in the amount of \$9,010.00 to John R. Sheehy, Trustee of the John R. Sheehy Trust, and Kimberly D. Sheehy, Trustee of Kimberly D. Sheehy Trust, in consideration for said easement.
