AN ORDINANCE amending the zoning districts established pursuant to the Unified Development Code by changing a certain 1.1 ± acre tract from District AG (Agricultural) to District RS (Residential Suburban).

ORDINANCE NO. 4988, June 12, 2017

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) District and the

"RS" (Residential Suburban) District, so that there will be transferred from District AG to District RS, a tract of land commonly known as 9311 S. Cyclone Lane, Lee's Summit, MO, specifically described as follows:

Description: Lot 25, Colborn & Cyclone Road Estates 2ns Plat, a subdivision in Jackson County, Missouri

Section 2. The Legislature, pursuant to the application of the Mark and Cynthia Cline (RZ-2017-551), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 5 to 0 to recommend APPROVAL of this application after a public hearing on May 18, 2017, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
