RESOLUTION #11508, November 18, 1996

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the Director of Purchasing pursuant to Section 1040.05 of the Jackson County Code, 1984, recommends the purchase of two Ford Taurus 4-door sedans for use by the Jackson County Drug Task Force and one Ford Ranger pick-up for use by the Public Works Department, from Shawnee Mission Ford of Shawnee, KS, in the aggregate amount of \$45,986.00, under the Joint Governmental Fleet bid, City of Lee's Summit, MO, Bid No. 67-003 of October 1, 1996, an existing government contract of the Mid-America Council of Public Purchasing; and,

WHEREAS, Section 1064.00, Jackson County Code, 1984, requires that, for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; and,

WHEREAS, in order to effect this purchase a transfer within the 1996 Anti-Drug Sales Tax Fund is necessary; and,

WHEREAS, the County Executive recommends such transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the following transfer be and hereby is made within the 1996 Anti-Drug Sales Tax Fund:
