RESOLUTION #12222, June 1, 1998

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, by Resolution 11543, dated December 9, 1996, the Legislature did authorize the County Executive to execute agreements with certain organizations which engage in drug treatment and rehabilitation activities; and,

WHEREAS, one of the agreements authorized by Resolution 11543 was with Children's Mercy Hospital, in the amount of \$26,243.00; and,

WHEREAS, Children's Mercy Hospital has requested an extension of time to allow for it to continue to provide services in connection with the continuation of its longitudinal study of drug exposed infants, at no additional cost to the County; and,

WHEREAS, the attached Addendum to Agreement provides a suitable mechanism by which to implement this extension; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Addendum to Agreement with Children's Mercy Hospital; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement and the Addendum thereto.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
