INTRODUCED BY Terry Young, County Legislator

WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract for the purchase of mobile radar units for use by the Sheriff's Department to Kustom Signals of Lenexa, Kansas, as its unit was evaluated as the best option in a Sheriff's Department field test; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that Kustom Signals of Lenexa, KS, is the only known supplier
