ORDINANCE # 3460, January 12, 2004

WHEREAS, the Missouri Department of Public Safety has awarded a Victim Services Advocates Grant in the amount of \$34,210.00 to the Prosecuting Attorney's Office to cover the salary and benefits for a victim advocate for its Victim Services Program; and,

WHEREAS, this grant is subject to a \$8,553.00 local match; and,

WHEREAS, a reappropriation and transfer are necessary to place the grant and matching funds in the appropriate spending accounts; and,

WHEREAS, the County Executive recommends said reappropriation and transfer; now therefore,
