ORDINANCE 2489, November 6, 1995

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, the County and the Southern Christian Leadership Conference (SCLC) desire to enter into an agreement, a copy of which is attached hereto and incorporated herein by reference, whereunder the County will pay \$30,000 to the SCLC to be used by SCLC for funding the 1996 King Birthday Celebration; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the unappropriated surplus of the 1995 General Fund to cover the funding for 1996 King Birthday Celebration:
