IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$35,000.00 from the unappropriated surplus of the 1998 Park Enterprise Fund and authorizing the County Executive to execute agreements with certain organizations to provide services in connection with the 1998 Christmas in the Park event, at a cost to the County not to exceed \$35,000.00.

ORDINANCE 2864, October 27, 1998

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, the Parks and Recreation Department will sponsor its 1998 Christmas in the Park event from November 25 to December 31, 1998; and,

WHEREAS, at this event, held at the Longview Lake Campground, visitors will tour by automobile lighted holiday displays erected by parks staff; and,

WHEREAS, the costs of the event are paid out of donations collected from those viewing the displays; and,

WHEREAS, the department has traditionally used workers from various community organizations to assist the department in traffic control and collecting donations at the event; and,

WHEREAS, as compensation for supplying the staff, the department proposes to pay each participating organization a share of the total proceeds collected for the event in an amount not to exceed \$1,000.00 per organization; and,

WHEREAS, for 1998, the department proposes to contract with the organizations listed on Attachment A for their services; and,

WHEREAS, the form contract attached as Attachment B provides a suitable mechanism for the implementation of this arrangement; and,

WHEREAS, in order to fund these contracts, an appropriation is necessary; and,

WHEREAS, the County Executive has recommended this appropriation as an amendment to her proposed 1998 Jackson County Budget; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the unappropriated

surplus of the 1998 Park Enterprise Fund be and hereby is made:

BE IT FURTHER ORDAINED that the Director of the Department of Finance be and hereby is authorized to make all payments including final payment on the agreements.
