**INTRODUCED BY** Bob Spence, County Legislator

WHEREAS, by Resolution 15186, dated October 18, 2004, the County Legislature did approve the County entering into a contract with Custom Lightning Service, LLC for the installation of a traffic signal at the intersection of Buckner Tarsney Road and Sni-A-Bar Road; and,

WHEREAS, unforeseen expenses associated with right-of-way acquisition resulted in a design change and an estimated \$10,000.00 increase in construction costs; and,

WHEREAS, the City of Grain Valley agrees to contribute \$10,000.00 toward the additional expenses under the terms of the attached Intergovernmental Cooperative Agreement; and,

WHEREAS, the installation of the traffic signal is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to sign the aforesaid contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
