ORDINANCE # 3667, August 29, 2005

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS the County has been awarded a grant from the Missouri Department of Public Safety to provide the City of Kansas City with funds to hire one full time victim advocate, two part-time attorneys, and to cover the costs of copier rental and travel and registration expenses for two conferences; and,

WHEREAS, the total project cost is \$158,834.00 and requires an in-kind match of \$84,372.00 which is being provided by the City of Kansas City; and,

WHEREAS, the City and the County have received approval from the Missouri Department of Public Safety for a proposed budget for the 2005 grant; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriations be and hereby is made within the 2005 Grant Fund:
