WHEREAS, pursuant to Resolution 10420, the County did, on July 1, 1994, enter into a Memorandum of Understanding with the City of Kansas City, Missouri, and the Kansas City, Missouri Board of Police Commissioners, regarding the Prosecuting Attorney's Drug Abatement Response Team (DART); and,

WHEREAS, pursuant to its terms, said Memorandum expired on June 30, 1995; and,

WHEREAS, the parties now desire to extend the DART program for an additional twelve months, so as to have a term coincident with the grant by the State of Missouri in support of this program; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Memorandum of Understanding with the City of Kansas City, Missouri, and the Kansas City, Missouri Board of Police Commissioners; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance be and hereby is authorized to make all payments, including final payment under the Memorandum...Attorney
