WHEREAS, the Jackson County Drug Task Force (JCETF) and the Federal Bureau of Investigation have formed the Organized Crime Drug Enforcement Task Force (OCETF) to conduct a joint federal drug investigation for the period of October 1, 2010, through September 30, 2011; and,

WHEREAS, the overtime costs incurred by the JCDF for this investigation will be reimbursed by the OCDEF, in the amount of \$4,500.00; and,

WHEREAS, an appropriation is necessary to place the funds in the proper spending account; now therefore,
