WHEREAS, on May 1, 1992, the County and Longview Horse Park Association ("the Association") entered into a Cooperation and Use Agreement, approved by the Jackson County Legislature by Ordinance 2089, whereunder the parties agreed to cooperate in the planning, development, improvement, operation, and use of an equestrian horse park center in the area of Longview Lake Park; and,

WHEREAS, subsequent addenda between the County and the Association have renewed this Agreement through the present; and,
