recommend approval of the proposed Memorandum of Understanding, a copy of which is attached hereto and incorporated herein by reference as Exhibit A; and,

WHEREAS, a sum of \$210,000 was set aside in the 2005 budget negotiations for one time salary adjustments which funds must now be used to fund this Memorandum of Understanding: and,

WHEREAS, a transfer is necessary to cover the costs of this Memorandum of Understanding; and,

WHEREAS, the approval of this Memorandum of Understanding is in the best interest of the health, welfare and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached Memorandum of Understanding is authorized to be executed by the County Executive on behalf of the County.
