WHEREAS, the Missouri General Assembly has awarded the County funding in the amount of \$1,000,000.00 for the restoration of the historic Truman/Jackson County Courthouse on the Square in Independence; and,

WHEREAS, the State has agreed to provide this funding on a fifty/fifty (50/50) match basis for expenses incurred during the restoration of the courthouse, as set forth in the attached Agreement for Reimbursement of Expenditures; and,

WHEREAS, the County now has available matching funds in the amount of \$1,000,000.00; and,

WHEREAS, an appropriation and transfer are necessary in order to place the State and County matching funds in the proper spending account; and,

WHEREAS, the County Executive recommends this appropriation and transfer as amendments to her proposed 2002 County budget; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation and transfer be and hereby are made:
