BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that, pursuant to Chapter 28, Jackson County Code, 1984, the Director of the Department of Finance is authorized to issue a check in the amount of \$173,088.00 to the City of Blue Springs for use in the City's 2002 street overlay program.
