INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the County desires to rent pagers and purchase airtime for use by various departments; and,

WHEREAS, the Director of Purchasing pursuant to Section 1040.05 of the Jackson County Code, 1984, recommends the rental of pagers and purchase of airtime from Mobilfone of Kansas City, MO, under an existing City of Kansas City, MO government contract; and,

WHEREAS, Section 1064.00, Jackson County Code, 1984 requires, that for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the purchase under the existing government contract be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payments on the contract, to the extent that sufficient appropriations to the using spending agencies are included in the then current Jackson County Budget. Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
