WHEREAS, the United States Executive Office of the President's Midwest High Intensity Drug Trafficking Area (HIDTA) Investigative Support Center has allocated a total of \$66,009.00 for fiscal

year 2007 for an investigative analyst to be retained on contract for use by the Jackson County Sheriff's Office; and,

WHEREAS, an appropriation is necessary to place these grant funds in the appropriate spending accounts; now therefore,
