WHEREAS, he has recommended that award be made to Cooke Sales & Service Co. of Chillicothe, MO, for the reason that it has submitted the lowest and best bid; and,

WHEREAS, the acquisition of this new motorgrader has rendered an existing 1985 Champion Model 8400 Motorgrader, MG-02, Serial Number 730A13714522282, as surplus property; and,

WHEREAS, pursuant to §1134., Jackson County Code, 1984, the Purchasing Director has requested that he be authorized to dispose of this 1985 Champion Model 8400 Motorgrader by way of trade-in; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to make all payments, including final payment on the contract; and,

BE IT FURTHER RESOLVED that the existing 1985 Champion Model 8400 Motorgrader, MG-02, Serial Number 730A13714522282, be and hereby is declared surplus property and the Purchasing Director be and hereby is authorized to dispose of it by way of trade-in.
