WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 56-00 for the furnishing of auto/truck drive line parts for use by the Public Works and Parks and Recreation Departments to provide for departmental needs for the upcoming one-year period; and,

WHEREAS, the only responsive bid received was from Precision Bilt Parts Co. of Kansas City, MO; and,

WHEREAS, the Purchasing Director has recommended that award be made to Precision Bilt of

Kansas City, MO, for the reason that it has submitted the lowest and best bid meeting specifications required as more fully set out in the attached recapitulation; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget.
