RESOLUTION # 16237, March 26, 2007

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, Section 1030.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source and requires notification of and approval by the Legislature on such sole source purchases exceeding \$25,000.00; and,

WHEREAS, the Finance and Purchasing Director recommends a contract with Metropolitan Soccer

Referee Association of Grandview, MO, for the furnishing of officiating services for the 2007 Adult Soccer Leagues for use by the Parks and Recreation Department; and,

WHEREAS, the Purchasing Director further recommends that it not take competitive bids with regard to said contract for the reason that Metropolitan Soccer Referee Association of Grandview, MO, is the only supplier of soccer officiating services in the Kansas City metropolitan area meeting the necessary requirements; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Finance and Purchasing Director be, and hereby is, authorized to execute for the County a twelve-month term and supply contract with Metropolitan Soccer Referee Association of Grandview, Missouri, for the furnishing of officiating services for the 2007 Adult Soccer Leagues for the Parks and Recreation Department; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments including final payment on the contract, to the extent that sufficient appropriations to the using spending agency are contained in the then current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
