A RESOLUTION authorizing the County Executive to execute addenda to the agreements with United Inner City Services and Boys & Girls Club of Greater Kansas City for their prevention programs, at no cost to the County.
RESOLUTION #11909, October 13, 1997

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, United Inner City Services and Boys & Girls Clubs of Greater Kansas City were authorized funding through Resolution 11763, dated May 19, 1997, in the amounts of \$55,250.00 and \$67,056.00, respectively, for their prevention programs upon the recommendation of the COMBAT Commission; and,

WHEREAS, the COMBAT Commission now recommends that the contracts with United Inner City Services and Boys & Girls Clubs of Greater Kansas City be amended; and,

WHEREAS, the addendum for the United Inner City Services would identify the Urban League of Greater Kansas City as the fiscal agent for its program and the addendum for the Boys & Girls Clubs would change the location of its program from the West Bluff neighborhood to the Clymer Neighborhood Center; and,

WHEREAS, these addenda are in the best interests of the health, welfare and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to enter into the attached addenda to the agreements with United Inner City Services and Boys & Girls Clubs of Greater Kansas City, in a form attached hereto. Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
