WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 108-98 for a term and supply contract for the furnishing of Chevrolet automobile O.E.M. parts for use by the Public Works and Parks and Recreation Departments to provide for their needs for the upcoming one-year period; and,

WHEREAS, the only response received was from Superior Chevrolet of Merriam, KS; and,

WHEREAS, the Purchasing Director has recommended that award be made to Superior Chevrolet of Merriam, KS, for the reason that it has submitted the lowest and best bid; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriation to the using spending agencies have heretofore been made in the current Jackson County budget...Attorney
