AN ORDINANCE repealing §§9057. and 9058., Jackson County Code, 1984, relating to the Housing Resources Commission and enacting in lieu thereof, two new sections relating to the same subject.
ORDINANCE #2862, October 19, 1998

INTRODUCED BY Fred Arbanas, County Legislator

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section A. Enacting Clause. Section 9057. and 9058., Jackson County Code, 1984, are hereby repealed, and two new sections enacted in lieu thereof, to be known as sections 9057. and 9058., to read as follows:

9057. Establishment of Housing Resources Commission.

There is hereby established the Jackson County Housing Resources Commission, consisting of nine members, who shall include the Legislator from the Second District, who shall serve as chairman, a member of the staff of the Legislative Auditor as [he] the Legislative Auditor shall designate, a member of the staff of the County Counselor as [he] the County Counselor shall designate, and six Jackson County residents who shall be appointed by the County Executive subject to disapproval by the County Legislature. One appointed member shall be a resident of each of the six County legislative districts. The term of each appointed member shall be three years; provided, however, that of the first appointments, two persons shall be appointed for three years, two persons for two years, and two persons for one year. Any vacancy on the Commission shall be filled by appointment and approval in like manner for the unexpired portion of the term. All members shall continue to serve until their successors have been

appointed and qualified. The Commission shall meet [in regular business meetings at least once every two months and may hold such additional meetings] from time to time as it deems necessary. A majority of the Commission shall constitute a quorum for the transaction of business. Each member of the Commission shall serve without pay but may be reimbursed from the special fund created by section 9056. for moneys actually and necessarily expended in the performance of their duties under sections 9054.-9058 [, but such reimbursement shall not exceed two and one-half percent of the fees collected annually pursuant to section 9054].

9058. Administration of Funds by Housing Resources Commission. The Commission shall allocate and disburse the funds collected and appropriated pursuant to sections 9054.-9057. in the manner provided and set forth in sections 67.1062 et seq., RSMo, as amended. Any contracts entered into under the authority of this section shall be subject to the approval of the County Legislature and executed on the County's behalf by the County Executive. The Legislative Auditor shall provide staff and administrative support for the Commission; the Commission shall not have the power to retain its own staff. To fund this support, the Legislative Auditor's budget may be supplemented out of the special fund created under section 9056., however in no event shall the amount budgeted for the Commission's total administrative expenses, including Legislative Auditor's staff and reimbursement of the expenses of Commissioners under section 9057., exceed two and one-half percent of the fees collected annually pursuant to section 9054.
