ORDINANCE # 2458, September 25, 1995

INTRODUCED BY Victor E. Callahan, County Legislator

WHEREAS, Tom Hayes, Jr, James Flanagan and Carl Bolte, Condemnation Commissioners previously appointed by the Judge of Division No. 1 of the Circuit Court of Jackson County, Missouri in Condemnation Case No. CV95-6317, entitled "Jackson County, Missouri vs. Rosie Burns, et al.", did on the 31st day of August, 1995, file their written report with the Circuit Court in Jackson County, Missouri, assessing damages in favor of the various parties defendant in said case; and,

WHEREAS, on the 30th day of August, 1995, the aforesaid Judge also made and entered his order allowing the aforesaid Commissioners fees and expenses in the amount of two thousand, two hundred dollars (\$2,200.00) each, to be taxed as costs payable by plaintiff, Jackson County; and,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made from the unappropriated surplus of the 1995 County Urban Road System Fund to cover the commissioners fees:
