WHEREAS, the Director further recommends that he not take competitive bids with regard to said

contract for the reason that G.W. Van Keppel Co., Inc., of Kansas City, KS, is the authorized

distributorship of parts for equipment manufactured by these manufacturers in the greater Kansas

City area; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

recommended by the Director of Finance and Purchasing, and that the Director be, and hereby is,

authorized to execute for the County any documents necessary to the accomplishment of the award;

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contract, to the extent that sufficient appropriations to the

using spending agency are contained in the then current Jackson County budget.
