WHEREAS, the Jackson County Drug Task Force (JCDTF) has been awarded a grant from the United States Office of National Drug Control Policy, High Intensity Drug Trafficking Area (HIDTA)

WHEREAS, the grant is awarded for the period of January 1, 2024, through December 31, 2025, and is not subject to a requirement for local matching funds; and,

WHEREAS, the Missouri State Highway Patrol will serve as the fiscal agent for this grant; and,

WHEREAS, an appropriation is necessary to place these grant funds in the appropriate spending accounts; now therefore,
