RESOLUTION # 12957, November 29, 1999

INTRODUCED BY Lisa White Hardwick, County Legislator

WHEREAS, the County desires to purchase automotive tires and tubes for use by various county departments; and,

WHEREAS, the Director of Purchasing pursuant to Section 1040.05 of the Jackson County Code, 1984 recommends the purchase of the automotive tires and tubes from Cross Midwest of Kansas City (Jackson County), MO, and Goodyear Commercial Tire of Kansas City (Jackson County), MO, under an existing City of Kansas City, Missouri government contract; and,

WHEREAS, Section 1064.00, Jackson County Code, 1984 requires that for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County Legislature for approval; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the purchase under the existing government contract be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payments on the contract, to the extent that sufficient appropriations to the using spending agencies are contained in the current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
