WHEREAS, Platte County, Missouri, a county of the first class, is required by §§ 58.700 and 58.705, RSMo 1994, to appoint a physician duly licensed by the Missouri state board of healing arts as Platte County's medical examiner; and,

WHEREAS, § 58.765, RSMo 1994, authorizes any two or more counties to, by contract, join in the appointment of a county medical examiner to serve all such counties and requires the counties' governing bodies to approve the contract, administer the appointment, and allocate the costs among the counties; and,

WHEREAS, Thomas Young, M.D., the duly appointed medical examiner of Jackson County, is fully qualified, ready, and willing to continue to serve as Platte County's Medical Examiner as well; and,
