ORDINANCE 3153, July 9, 2001

WHEREAS, the Missouri Department of Public Safety has awarded the Prosecuting Attorney's office a grant in the amount of \$39,300.00 as funding for its Victim Services Volunteer Coordinator Program; and,

WHEREAS, this program serves crime victims; and,

WHEREAS, said grant is subject to a \$7,962.00 local match for which a transfer and appropriation are necessary; now therefore,
